PROJECT CALLOUT

The Creative Directors are seeking submissions of architectural works from Australia and across the Pacific region that strengthen cultural understanding between non-indigenous and First Nations people.



SUBMISSION REQUIREMENTS

THE CALL OUT

The call out is open to architects from Australia and the pacific region and/or collaborations between architects, urban designers and landscape architects. Teams of multidisciplinary practitioners are encouraged. The team or collaborations must include at least one architect who is a member of the Australian Institute of Architects.

Preference will be given to built works however unbuilt projects that can demonstrate consistency with the thematic of 'In |between' will also be considered. Contemporary or historical architecture or multi-disciplinary projects consisting of architecture/urban design/landscape architecture are also eligible, providing the projects were initiated or built within the last 10 years.

Projects previously exhibited with the Australian pavilion or the Venice Architecture Biennale are not eligible for submission. Works can be of any scale, context or program, excluding residential projects.

Works will illustrate an understanding of Country, being the relationship to where the project is physically, spiritually and/ or environmentally located. In addition, the works will in some way have a dialogue, sensibility or connection to notions of representation, identity, diversity or culture. The entry will exhibit the characteristics, including the revealing of the often hidden processes of how a range of voices are reflected, given agency or provide design inspiration.

The Creative Directors are interested in exploring the roles and responsibilities of architects as often cultural interlocutors, demonstrating a responsibility or social contract in a practitioner's meaningful role to speak to our authentic stories.

SELECTION PROCESS

The selection process will be carried out by the Creative Directors in one stage with up to 20 projects taking into consideration their aim to represent a geographic, scale and project-type mix. Projects that are selected will be determined based on the information provided and will further seek a cultural lens by a select group of Indigenous voices, acting as a cultural brains trust.

The ultimate decision will rest with the Creative Directors supported by the creative team. Projects will also be included in the official Australian Pavilion catalogue or supporting collateral. Projects that are not selected for exhibition may also be included.

WHAT IS TO BE SUBMITTED

Using the template, submissions are asked to respond to the following questions:

- Project title, program/s, location (Country, state, bioregion) and team.
- Detail the language group/s, tribe or Nation in which the project is located. Has any non-English language been used within the project?
- Provide a project description. (max. 200 words)
- Were traditional Owner Group/s consulted as part of the project? If so, who was the representative/s or organisation/s consulted? Is the submission endorsed by a member of the relevant Aboriginal and Torres Strait Islander community?
- How does the project connect to or evoke Country? What do you regard as the site? (max. 150 words)
- What process/es of engagement were used to enhance the project aspirations? (max. 150 words)
- What approach (if any) was used to acknowledge, connect or build understanding with one's neighbours to the project? (max. 100 words)
- How has the project enhanced an Indigenous voice/s or agency?

Please provide 4 images:

- One that represents the way the project addresses connection to Country
- One that represents the way the project addresses an Indigenous voice/s
- One of the submitter's choice
- One page of drawing/s, being a plan, site plan, territorial plan, and/ or section as required to communicate the project






